Our School's Mission Statement

What is the Pupil Premium?

The Pupil Premium is additional funding for publicly funded schools in England to raise the attainment of disadvantaged pupils and close the gap between them and their peers. This funding is aimed at addressing the current underlying inequalities that exist between children from disadvantaged backgrounds and their more affluent peers.

This funding is allocated to schools on the basis of the number of pupils who have been eligible for Free School Meals at any point over the last six years; children who have been "looked after" for more than six months, children who have left local authority care or children of service personnel.

The DFE has given us the freedom to use the Pupil Premium as we see fit, based on the knowledge of our pupils' needs.

Pupil Premium Funding

For the academic year 2018 – 2019, we have received £91,080 in Pupil Premium funding.

Nature of Support

At St Ann's R C Primary, we continue to use the additional funding to support a variety of strategies to best meet the needs of each individual child for whom the grant funding was allocated, including:

- high quality, inclusive teaching
- precision teaching by the class teacher and TAs
- pupils taught in groups with other pupils who are working at a similar level
- focused support from skilled teaching assistants, both in class and in small groups

- individual tuition, by an experienced teacher or teaching assistant
- intervention groups run by teaching assistants/teachers eg. Phonics Booster Groups, Reading Support, Listening Skills Groups, Ruth Miskin Literacy, Lego Therapy, Numeracy Support.
- carefully targeted resources known to raise attainment
- personalised support including social and emotional groups, pastoral support for individual pupils and their families, to meet their needs
- supporting parents to fund clubs, private tuition and trips.

 All interventions are matched to the needs of the pupil and the impact is measured.

Monitoring the impact of Pupil Premium Grant

The Headteacher, Mr O'Brien, SENCO, Mrs Gibbons and Learning Mentor, Mrs Grogan have overall responsibility for the attainment and progress of Pupil Premium children through ensuring the progress of eligible pupils and evidencing this as a whole-school priority. Mr O'Brien is Pupil Premium Grant (PPG) Lead.

Children's progress and attainment is tracked and monitored carefully to ensure they achieve their full potential. Regular monitoring and evaluation is key to ensuring effectiveness of expenditure.

Targets for pupils are set in maths, reading and writing and we know where we expect them to be by the end of the programme or intervention period. Monitoring is a joint responsibility of the class teacher and Senior Leaders and regular assessment data is analysed and acted upon. All pupils eligible for Pupil Premium funding are discussed at termly pupil progress meetings. The DFE and LA also analyse our school data and compare our results to national data.

Through our termly Curriculum Committee meetings we report clearly on data for Pupil Premium and the use of Pupil Premium funding forms part of the monitoring of the Finance Committee so governors can link value for money with impact. There is an identified governor for Pupil Premium.

2018/19 Objectives

<u>Pupil Premium Action Plan Objective 1</u>: to ensure Quality First Teaching (QTF) and provide targeted interventions enabling every PP pupil every PP pupil to make at least expected progress and be on track for achieving age-related expectations by the end of Year 6.

How will we meet this objective?

At St Ann's R C Primary, provision is tailored to meet the needs of every individual PP pupil. This will be led by Mr O'Brien, Lead PPG, who will support and oversee all disadvantaged pupils through targeted support and intervention.

<u>Pupil Premium Action Plan Objective 2</u>: to provide personalised, targeted pastoral support for individual PP pupils to enable them to be happy, secure and fully engaged in school and supported (where appropriate) outside school.

How will we meet this objective?

At St Ann's R C Primary, provision is tailored to meet the needs of every individual PP pupil. The combination or all of following strategies will be used:

- Discussions between Headteacher, Class teacher, external agencies and parents in identifying the social and emotional needs of individual pupils and the most appropriate support. This support may include any of the following:
 - TA/Learning Mentor in order to support small groups of children and work 1:1 on developing social skills, self-esteem and positive behaviour

Mentor in delivering programmes focused on pastoral care Involvement of outside agencies eg. Longford Park Outreach, Educational Psychologist.
